I hereby waive, release, absolve and indemnify and agree to hold harmless, Southwest Playhouse Inc., its organizers, sponsors, supervisors, and participants from and against any claim for damage, injury, loss or death of my child (other than claims that arise as the direct result of active or foreseeable negligence) resulting from participation in any class, program, play or other activity either at Southwest Playhouse or at another location including any damage, loss or injury resulting from any failure to abide by the rules as explained to my child by Southwest Playhouse representative(s) upon onset of activity. #### **Tuition Cost/Dates/Times**

Cost is \$300 per student (5th-12 grade)(including 2024 graduating seniors), or \$275 per student if parent/guardian has two (2) or more students (5th-12th grade) attending *Camp Santa Fe.* **2nd-4th graders(2024-2025)must have participated in a previous children's camp with Southwest Playhouse or a SWPH full show to be eligible for Camp Santa Fe and may be required to audition due to limited spaces available for this age group, parents/guardians will be notified of the status of the audition process for this age group.** A Student Liability Waiver & Release, Permission & Registration Form, Press Release and an Assumption of Risk form must be completed and signed for each student participating before the student will be allowed to participate in *Camp Santa Fe* (if you have more than one student you will need to complete and sign all forms for each participating student). Tuition must be paid in full when submitting **ALL** required forms. Payment methods accepted for *Camp Santa Fe* are check or money order (made payable to Southwest Playhouse). *Camp Santa Fe* is from 1:00-5:00, Monday - Friday, **June 3-28** and **July 8-12, 2024**. Tech weeks will be **July 14-18, 2024** with those rehearsal times TBD. *Disney's Newsies* performances will be **July 19-21** and **July 25-28**.

## **Camp Size**

**ALL** registration forms and payment must be received by April 1, 2024 unless capacity is reached before the deadline. **NO EXCEPTIONS!** Camp size will be limited to keep it enjoyable and comfortable for all. Forms received after capacity is reached will be placed on a waiting list and participant will be notified. Please mail/submit your registration early. **Camp registration is not guaranteed until you receive a confirmation call and/or email.** (Calls/emails should not be expected until after April 7, 2024).

#### **Refunds/Cancellation**

Cancellations prior to May 28, 2024 will be reimbursed paid camp fee. Cancellations after May 28, 2024 will not receive a refund or credit. Fees for camps cannot be transferred to other Southwest Playhouse Inc. events. Size or nature of roles is at the professional discretion of instructor/directors. All roles provide a valuable learning experience. No refunds will be granted due to dissatisfaction with assigned role.
